PART 1: OFFER FOR THE REFERRER

OFFER FOR PARTICIPATION IN THE ZALEYCASH PARTNER PROGRAM FOR THE REFERRER

1. General Provisions

1.1. This Offer (hereinafter referred to as the "Offer") is an official proposal from <https://zaleycash.com> (hereinafter referred to as the "Company") to an individual or legal entity (hereinafter referred to as the "Referrer") wishing to participate in the ZaleyCash partner program and attract new users to the service.

1.2. Participation in the partner program implies the Referrer's full agreement with the terms of this Offer and its acceptance in full.

1.3. The current version of the Offer is always available on the website <https://zaleycash.com>.

1.4. The partner program offers an opportunity for long-term passive income through attracted clients who continue working with the service.

1.5. The Referrer gains access to a transparent calculation system, flexible cooperation conditions, and extended functionality for managing their partner network.

2. Participation in the Partner Program

2.1. The Referrer gains access to a unique referral mechanism that allows attracting new clients to ZaleyCash and earning rewards from their turnover in the service.

2.2. Within the program, the Referrer independently sets the bonus distribution conditions between themselves and the invited clients (Referrals), ensuring flexibility in income management.

2.3. ZaleyCash provides the technological infrastructure for tracking and automatically crediting bonuses but does not interfere in the process of setting conditions within the Referrer's structure.

2.4. The amount of bonuses received by the Referrer depends on their grade within the system, their total personal turnover, and the turnover of all their attracted clients and partners.

2.5. Changes in the Referrer's grade level may affect the bonus distribution conditions within their partner network. Changes take effect from the 1st of the month following the reporting period and are recorded in the personal account.

2.6. Referrers have access to detailed analytics on their partner streams, allowing them to track the effectiveness of client acquisition.

3. Rights and Obligations of the Parties

3.1. The Referrer undertakes to:

- Attract clients and partners while adhering to ethical standards and platform rules.
- Independently manage the bonus distribution conditions within their structure.
- Provide up-to-date information to their Referrals and answer their questions regarding bonus conditions.
- Use the provided marketing materials and tools for effectively promoting the partner program.

3.2. The Company undertakes to:

Provide technical support and automated bonus accrual.

Offer analytical tools for convenient management of the partner structure.

Not interfere in individual agreements between the Referrer and their Referrals.

Regularly update and improve the platform to enhance the user experience of the partner program.

4. Financial Conditions and Payments

4.1. The Referrer earns a reward from the turnover of their referrals in accordance with the current program conditions.

4.2. Payments are credited based on the results of the period (month) in the following month, from the 1st to the 15th, after confirmation of ad spend verification from advertising networks.

4.3. Payments are credited to the Referrer's personal account and can be withdrawn using any of the methods available in the ZaleyCash service after verification.

4.4. All transactions and accruals are transparent and displayed in the Referrer's personal account.

4.5. Referrers receive priority support and access to special conditions depending on their level of activity and the volume of attracted traffic.

4.6. ZaleyCash is not responsible for financial settlements between the Referrer and their Referrals if they were established outside the platform.

5. Liability and Limitation of Warranties

5.1. ZaleyCash reserves the right to block the Referrer's account in case of any attempts to bypass the system, fraud, or violations of the partner program terms.

5.1.1. Attempts to bypass the system include any actions aimed at manipulating the partner program mechanisms to obtain unjustified income, including but not limited to:

- Creating fake accounts to receive referral bonuses.
- Using automated systems to generate false activity.
- Artificially increasing the grade through fake transactions.

5.1.2. Fraud includes actions that mislead the platform or Referrals, including:

- Deceiving clients or partners regarding cooperation terms.
- Falsification of data or document forgery.

5.2. The Company does not guarantee a fixed income level and is not responsible for the conversion of attracted clients.

5.3. In case of disputes related to bonus conditions within the Referrer's structure, all issues are resolved exclusively between the participants of the partner program without ZaleyCash's involvement.

6. Changes to the Partner Program Rules

6.1. ZaleyCash reserves the right to make changes to the rules of the partner program, including percentage conditions for all participant levels, if required by changes in company policy or market adaptation.

6.2. All changes take effect on the 1st day of the month following the reporting period, with mandatory notification to participants in their personal account.

7. Final Provisions

7.1. Registration in the partner program confirms that the Referrer has read and unconditionally accepts the terms of this Offer.

7.2. If the Referrer disagrees with the terms of this Offer, they must cease participation in the partner program.

PART 2: OFFER FOR THE REFERRAL

OFFER FOR PARTICIPATION IN THE ZALEYCASH PARTNER PROGRAM FOR THE REFERRAL

1. General Provisions

- 1.1. This Offer (hereinafter referred to as the "Offer") is an official proposal from ZaleyCash (hereinafter referred to as the "Company") and defines the terms of participation for the client (hereinafter referred to as the "Referral") in the ZaleyCash partner program.
- 1.2. Participation in the partner program implies the Referral's full and unconditional acceptance of all provisions of this Offer and agreement to its terms without any exceptions.
- 1.3. The current version of the Offer is available on the official website: <https://zaleycash.com/>.

2. Participation in the Partner Program

- 2.1. The Referral becomes a participant in the ZaleyCash partner program after registering through a unique link provided by their Partner (hereinafter referred to as the "Referrer").
- 2.2. Participation in the partner program allows the Referral to receive cashback on advertising network top-ups made via ZaleyCash under the conditions set by their Referrer.
- 2.3. The Company does not establish individual terms between the Referrer and the Referral and bears no responsibility for agreements made between them.

3. Rights and Obligations of the Parties

3.1. The Referral undertakes to:

- Use the partner program exclusively within the framework established by this Offer.
- Not violate the participation terms or exploit the program for abuse.
- Direct all inquiries regarding cashback accrual conditions and other bonuses exclusively to their Referrer.

3.2. The Company undertakes to:

- Provide the Referral with access to information on accrued cashback and partner program conditions in their personal account on <https://zaleycash.com/>.
 - Notify the Referral of significant changes in the partner program terms via the notification system.

4. Changes in Participation Terms

4.1. The terms for receiving bonuses and cashback set by the Referrer can only be modified by the Referrer. Any requests for adjustments must be directed to the Referrer.

4.2. The cashback percentage granted to the Referral depends on the Referrer's grade level in the system. If the Referrer's grade level changes, their cashback accrual percentage may also be revised.

4.3. Any changes in cashback accrual terms take effect on the 1st day of the month following the reporting month in which the Referrer's level was changed.

5. Liability Limitations

5.1. ZaleyCash is not responsible for any disputes between the Referrer and the Referral regarding the distribution of bonuses or other terms established between them.

5.2. If violations, fraudulent attempts, or dishonest use of the program are detected, the Company reserves the right to block the Referral's account and cancel any accrued bonuses.

6. Changes to the Partner Program Rules

6.1. ZaleyCash reserves the right to make changes to the partner program rules, including percentage conditions for all participant levels, if required by company policy updates or market adaptation.

6.2. All changes take effect on the 1st day of the month following the reporting period, with mandatory notification to participants in their personal accounts.
